Workshop objectives:

Social justice remains an enduring, if at times muted, driver of social policy. At the city scale, this normative imperative is increasingly being encapsulated through the notion of spatial justice - an attempt to conceptualise, and render actionable, the complex interplay of relations between distribution, recognition, governance and territory. Spatial justice is a bold and vivid concept, inherently dynamic and political and, as such, warrants closer scrutiny. This workshop represents a rare opportunity to unpack the concept through the lens of its linguistic and conceptual appropriation in Anglophone and Francophone literatures, as well as its varied translation(s) into urban policy. Supported by the Labex Urban Futurs (Université Paris-Est), the seminar will bring together colleagues from the Bartlett's Development Planning Unit and the Department of Geography at UCL and from Université de Paris Est (UPE), especially the JEDI research group (Justice Espace Discriminations et Inégalités).

Some key objectives of the workshop include:

• Reflecting on spatial justice from different disciplinary and theoretical vantage points (political theory, urban planning, geography) and different contexts in the global north/south.

• Questioning critically the divide between so-called 'French' and 'Anglo' perspectives on (spatial) justice and how they translate in urban policy (targeting groups vs. spaces for instance), as well as their international circulation.

• Presenting different methodologies to study theoretically and empirically the notion of spatial justice with an attention to actual mechanisms allowing for redistribution in urban contexts.
